Can you cut your Council Tax?

Keeping up to date with your Council Tax should always be a priority, even if you're on a tight budget. Staying on top of your bill can include making sure you receive any discount or exemption you might be entitled to, so that you aren't charged more than is necessary. Depending on your circumstances, discounts can sometimes cover as much as 100% of your bill but some people miss out because they simply don't apply. It's always worth checking whether you might be able to get help.

Council Tax Reduction

Many people can reduce their bills through a discount called 'Council Tax Reduction' or CTR, which helps people on low incomes. It takes account of your full financial and household circumstances. Use our online calculator to see if you might be entitled. If you visit us at

The calculator is built into our online application form. If it shows that you are likely to be entitled to CTR, just carry on with the questions to submit a claim.

Other discounts and exemptions.

There is a range of other discounts or exemptions that you might qualify for. For example 'Single Occupier Discount.' This is where someone is the only person in their home aged over 18 and they are not a full time student. They can receive a 25% discount. Or, you might be exempt if you are a student yourself. All discounts and exemptions have conditions attached; more information is available at

If you are awarded a discount or exemption and your financial or household circumstances change, you must inform us as soon as possible or you may face a penalty.
