#### Introduction

The Regulatory Reform (Fire Safety) Order 2005 (RR(FS)O) places a legal duty on landlords to complete a fire risk assessment (FRA). Specifically, RR(FS)O article 9. — (1) "The responsible person must make a suitable and sufficient assessment of the risks to which relevant persons are exposed for the purpose of identifying the general fire precautions he needs to take to comply with the requirements and prohibitions imposed on him by or under this Order".

This fire risk assessment has been written to comply fully with the above legislation which is enforced locally by West Midlands Fire Service. The date of the fire risk assessment is on the front page, followed by any subsequent reviews. A recurring time frame is not set in legislation, but the Council will as a minimum review:

- High Risk Residential Buildings annually
- Other Buildings every 3 years

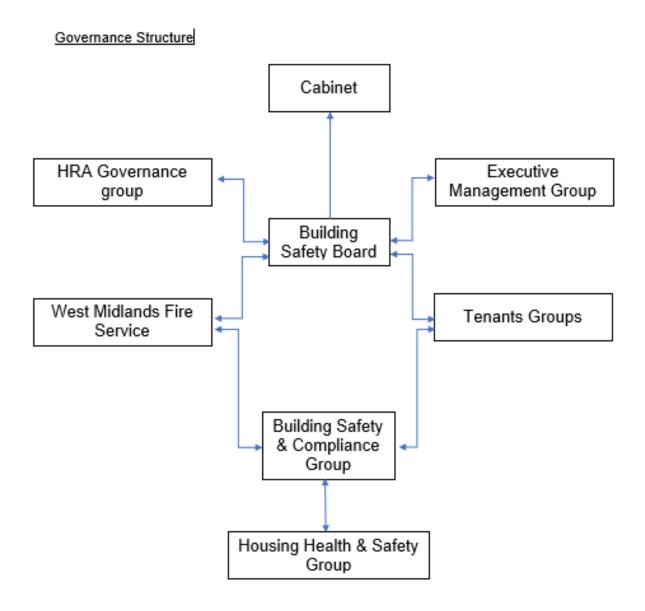
The council has procedures and policies in place that will trigger a review of the fire risk assessment. This then is recorded on the fire risk assessment. If the review suggests the fire risk assessment is not currently suitable and sufficient, then a new fire risk assessment will be undertaken and become the current fire risk assessment. The previous fire risk assessment will be retained in the building safety case for that building.

The following diagrams illustrate those procedures and persons that support the effective planning, organisation, control, monitoring and review of the preventive and protective measures. This information is provided as required under the RR(FS)O.



The above processes and procedures are overseen by the Fire Safety, Manager who reports to the Head of Building Safety

These managers attend the Building Safety and Compliance Group for scrutiny which is part of the governance structure below.



To summarise the fire risk assessment, in this scenario the RR(FS)O requires the prescribed information to be recorded. The prescribed information is the significant findings of the fire risk assessment and those groups or persons especially at risk from fire. This is recorded here in <a href="section 1">section 1</a>. Also required to be recorded under article 11, are the fire safety arrangements for the planning, organisation, control, monitoring and review of the preventative and protective measures. The information shown above is part of this requirement.

### Significant findings

The significant findings (executive summary) of the fire risk assessment include those measures that have been or will be undertaken by the responsible person in order to comply with the RR(FS)O 2005. Groups of people especially at risk of fire include such people as remote or lone workers, at risk due to layout of the building, visitors and contractors unfamiliar with the building layout as well as those with physical, sensory or mental health issues.

A third requirement that under the order must be recorded is the fire safety arrangements. This is the effective planning, organisation, control, monitoring and review of the preventive and protective measures. These are shown in the introduction.

#### Significant findings

Include a brief summary of protective and preventative measures where relevant along with any issues found;

The escape strategy is 'Stay Put Unless'. This means in the event of a fire in your flat you should evacuate. If there is a fire elsewhere in the building you should stay put unless you are affected by fire, smoke or you have been advised by the emergency services to leave.

#### Comments

In conclusion, the likelihood of fire is at a medium level of risk prior to the implementation of the action plan because of the presence of normal fire hazards for this type of occupancy which have all been highlighted within the fire risk assessment.

After considering the use of the premise and the occupants the consequences for life safety in the event of a fire would be slight harm.

This is due to there being a Stay Put Unless policy and sufficient compartmentation to include predominately nominal Permadoor FD30s doors to flat entrances combined with suitable smoke detection to LD2 standard within flats.

Overall, the level of risk at the time of this FRA is Tolerable.

A suitable risk-based control plan should involve effort and urgency that is proportional to risk. The following risk- based control plan is based on one that has been advocated for general health and safety risks:

Risk level	Action and timescale									
Trivial	No action is required, and no detailed records need to be kept.									
Tolerable	No major additional fire precautions required. However, there might be a need for reasonably practicable improvements that involve minor or limited cost.									
Moderate	It is essential that efforts are made to reduce the risk. Risk reduction measures, which should take cost into account, should be implemented within a defined time period. Where moderate risk is associated with consequences that constitute extreme harm, further assessment might be required to establish more precisely the likelihood of harm as a basis for determining the priority for improved control measures.									
Substantial	Considerable resources might have to be allocated to reduce the risk. If the premises are unoccupied, it should not be occupied until the risk has been reduced. If the premises are occupied, urgent action should be taken.									
Intolerable	Premises (or relevant area) should not be occupied until the risk is reduced.									

(Note that, although the purpose of this section is to place the fire risk in context, the above approach to fire risk assessment is subjective and for guidance only. All hazards and deficiencies identified in this report should be addressed by implementing all recommendations contained in the following action plan. The fire risk assessment should be reviewed regularly.)

### **People at Significant Risk of Fire**

Persons at significant risk of fire does not just refer to those people with physical, sensory or mental health issues. It also includes those at risk due to the layout or features of the building such as inner rooms or dead-end conditions. Persons may also be at risk due to remote or lone working.

The RR(FS)O requires that these people are identified in any fire risk assessment.

Sandwell Council takes the health, safety and wellbeing of its colleagues, contractors, residents and leaseholders seriously. It is our policy to exceed, where possible, the minimum health and safety requirements of the law.

Residents are responsible for letting us know whether they might need a Personal Emergency Evacuation Plan (PEEP). The Resident Engagement Officers (Fire Safety) will conduct an assessment visit upon request. Any risk-reduction measures that are found where a PEEP is necessary and completed will be documented and taken quickly. With the consent of the resident, we will make a referral for West Midlands Fire Service to conduct a Safe and Well visit.

When a PEEP is in place, the relevant information will be kept in the secure Premise Information Box (High Rise Buildings only), which is set up to help WMFS in an emergency. The data is classified as level 1, which means it complies with the General Data Protection Regulations.

## **Description of Premises**

Moseley Street (2-12) DY4 0JT Walker Street (42-52) DY4 0JS Cotterill's Farm Tipton

#### **Description of the Property**

The property was built in 1965 and is of traditional brick construction. The property has 2 storeys inclusive of the ground floor.

The block consists of 6 ground floor flats and 6 deck access first floor flats. The block has a single staircase. Deck width is 1.6 metre and staircase width is 1 metre.

The block has one main entrance to the front elevation. A door entry system with a fob reader is installed.



The property has a pitched roof.



The communal, any workplace areas and the external envelope of the building are subject to the Regulatory Reform (Fire Safety) Order 2005 as confirmed by the Fire Safety Act 2021.

The enforcing authority is West Midlands Fire Service.



# **Building Plan**



### **External envelope**

Following the introduction of the Fire Safety Act 2021, consideration needs to be given to the external envelope of the building for any fire risk. This predominantly means the external wall construction including any insulation filler. It also includes balconies and any other fixtures as well as doors and windows.

Below is a breakdown of the materials used within the external envelope and, as part of the external wall system.

It is deemed that the combination and application of these materials presents an acceptable level of fire risk.

1) The exterior of the buildings is predominantly traditional brick construction with concrete access decks at rear.







2) Stairs are naturally ventilated at ground and first floor as not enclosed at rear.





3) Front entrance doors are predominately nominal FD 30s Permadoor.





4) The block has a pitched concrete tiled roof.



## **Means of Escape from Fire**

1) The site has one staircase that provides a means of escape.





2) The means of escape are protected to prevent the spread of fire and smoke with predominately nominal Permadoor FD30s doors. Flat entrance door 52 is timber.





3) Brickwork, on external escape route, is approx. 1300mm to bottom of window. This is deemed acceptable for a person to crouch and pass the window. Please note a stay put unless strategy applies to this building.



4) Electric meter cupboards are fibreglass or steel modular units fitted with budget locks, located outside.



5) Automatic smoke ventilation is not employed. This is acceptable as decks and stair are open to air therefore providing permanent ventilation.





6) Communal areas are kept free of flammable items. The communal areas are checked on a regular basis by Janitorial/ Cleaning teams. There is also an out of hours service that allows combustible items of furniture / rubbish to be removed.



Good housekeeping is fundamental to reducing risk in blocks of flats. Controlling the presence of combustible materials and ignition sources not only reduces the potential for accidental fires to start and develop in the common parts, it also significantly reduces the scope for deliberate fires. It also ensures escape routes are free of obstructions

that might hinder the evacuation of people from the building and access for fire-fighters.

7) Emergency lighting is provided to the stairs and open decks.



- 8) The building has sufficient passive controls that provide effective compartmentation in order to support a Stay Put-Unless Policy. Therefore, residents are advised to remain in their flat unless the fire directly affects them or if they are advised to evacuate by the emergency services.
- 9) Several flat entrance doors have steel gates in front of them. These are acceptable if not locked. Email sent to housing manager to advise tenants not to lock these doors. During the risk assessment resident conformed that these gates are not locked.

11) Resident confirmed rear area previously had another access gate. Consideration should be given to reinstating this during the next programmed works to allow an alternative route of travel away from the block.



12) Items of furniture were noted outside flats at ground and first floor level. Due to the residual deck widths (1.2m) and the low risk that the block presents the present situation has been deemed acceptable. Email sent to the housing manager requesting that the situation is monitored, and action taken if situation worsens.

### Fire Detection and Alarm Systems

- Early warning is limited to hard wire or battery smoke alarms within each of the resident's flats. The equipment is subjected to a cyclical test.
- 2) Internal access to flats 46 and 44 was gained during this fire risk assessment. Fire detection installed to an LD2 standard.

For information

LD1 all rooms except wet rooms

LD2 all-risk rooms e.g., Living Room, Kitchens and Hallway.

LD3 Hallway only

- 3) There is no effective means for detecting an outbreak of fire to communal areas in the remaining blocks. The reason for this is:
  - I. Such systems may get vandalised.
  - II. False alarms would occur.
  - III. A Stay Put Unless policy is in place.

### **Emergency Lighting**

1) The premises has sufficient emergency / escape lighting system in accordance with BS 5266 and has test points strategically located.





- 2) The self-contained units are provided to the stair and open decks..
- 3) All installed equipment is checked and tested on a monthly basis by Sandwell MBC in house electrical team or approved contractor, in accordance with current standards. Confirmation requested from electrical engineers by email.

## Compartmentation

This section should be read in conjunction with Section 4

- 1) The building is designed to provide as a minimum 60-minute vertical fire resistance and 60-minute horizontal fire resistance. Please note the block is designed as open deck access therefore it is acceptable for non-fire rated windows to be adjacent to the deck. It is acceptable to have 30-minute flat entrance doors in a 60minute wall.
- 2) The premises do not have sufficient compartmentation to limit the travel and effect of smoke and flame in event of a fire in communal areas due to the open plan staircase.
- A variety of methods / materials have been used to achieve firestopping including Rockwool, fire rated sponge and intumescent pillows.
- 4) The fire stopping / compartmentation is subject to an annual check by the Fire Safety Rapid Response Team.
- 5) Any remedial works arising from the fire stopping / compartmentation check(s) will be actioned immediately by the Fire Safety Rapid Response Team.
- 6) The building has sufficient passive controls that provide effective compartmentation to support a Stay Put -Unless policy. Therefore, residents are advised to remain in their flat unless the fire directly

affects them or if they are advised to evacuate by the emergency services.

8) Access could not be gained into the roof space during the fire risk assessment as the panel was fixed shut.



9) Store doors located next to flat entrance doors and to underside of staircase should be considered for upgrading works to certified FD 30s door sets during the next future works programme.



10) Flat entrance door 52 is scheduled to be changed to a certified self-closing FD 30S as confirmed by door programme manager. This door is located at the end of the block and is not on a travel route therefore is of low risk.

# **Fire Fighting Equipment**

1) The premise has no provision for firefighting equipment.

## Fire Signage

- Fire Action Notices are not displayed throughout the building.
  The signs are not necessary due to the building not having a
  complex layout.
- 2) Smoking is prohibited within any communal parts of the building in line with Smoke Free England Legislation.



3) Yellow LPG warning signs are not displayed.

# **Employee & Resident Training/Provision of Information**

- 1) All Caretaking / Cleaning Employees have undertaken fire safety training. This includes use of bespoke 'Fire Safety in High / Low Rise Flatted Accommodation' Video.
- All employees are encouraged to complete 'In the line of fire' training on an annual basis.
- Caretaking Teams are not currently trained in the effective use of fire extinguishers. Caretaking Teams are not expected to tackle fires in this area.
- 4) Staff undertaking fire risk assessments are qualified to or working towards Level 4 Diploma in Fire Safety.

- 5) Fire safety information has been provided as part of tenancy pack.
- 6) Information regarding use of fire doors is provided to residents.



7) Information regarding the Stay Put unless fire evacuation strategy is provided to residents.

## **Sources of Ignition**

 Smoking is prohibited within any communal parts of the building in line with Smoke Free England legislation. Evidence of smoking and lighted candle was witnessed. Email sent to housing manager requesting residents are reminded that smoking and lighting of candles is prohibited.





- 2) Hot working is not normally carried out. If essential maintenance requires the use of hot work processes, then corporate policies and procedures are to be followed.
- 3) Portable electrical equipment used as part of the Caretaking / Cleaning regime is subject to annual PAT Testing. This information is held by the Estate Services Manager Bryan Low.
- 4) The fixed electrical installation shall be tested every 5 years. At the time of the Fire Risk Assessment, it was not possible to ascertain the date of the last test.
- 5) Portable heaters are not allowed in any common parts of the premises.
- 6) Gas appliances and pipework (where installed) are subject to annual testing and certification. This cyclical contract is managed by the in-house Gas Team.



7) Barbeque noted in rear area. Email sent to housing manager requesting that residents remove the barbeque as not permitted.



#### **Waste Control**

- 1) There is a regular cleaning service to the premises.
- Regular checks by Caretakers minimise risk of waste accumulation.



3) There is an 'Out of Hours' service in place to remove bulk items.

# **Control and Supervision of Contractors and Visitors**

- Responsive Repairs service delivered by Sandwell MBC necessitates the production of an order via the computerised repairs system. Details of any known risks are documented on the repair order.
- 2) Hot works are not permitted unless authorisation is given via the approved officer. The hot works procedure is to be followed.
- Owing to the nature of Low-Rise flatted accommodation, it is difficult to manage / control individual contractors / utility companies.

- 4) However, utility companies are not allowed to access any service cupboard or secure area. They must request and collect maintenance keys from the local housing team. This allows scrutiny of what is the scope of any works such as installation of tenant's broadband / phone line etc.
- 5) Where contractors are appointed to undertake major refurbishment works, Sandwell MBC Urban Design team will put control measures in place. Such Measures include:
  - a) Pre-Contract Meetings where contractor is made aware of all working arrangements and safe systems of work to be adopted. Issues covered in this meeting will include:
    - Health and Safety.
    - Site security.
    - Safety of working and impact on children/school business.
    - Fire risk, if any.
      - Site Emergency Plan.
  - b) Monthly Site Meetings in order to monitor, review and share any new information including any new risks.
  - c) Site monitored daily whilst work is in progress by Clerk of Works / Health and Safety Officers.
  - d) Final Contractor review on completion of works undertaken.

#### **Arson Prevention**

- 1) Regular checks are undertaken by Janitorial / Cleaning Teams which helps reduce the risk of arson.
- 2) There is current evidence of arson.
- 3) The perimeter of the premises is well illuminated.
- 4) There have been no fire related incidents since the previous FRA.

### **Storage Arrangements**

- 1) Residents instructed not to bring L.P.G cylinders into block.
- 2) The tenancy conditions, Section 7 Condition 5.6 stipulates "If you live in a flat or maisonette, you, people living with you and any visitors to your property must not keep or use paraffin oil, petrol, bottled gas appliances or any other explosive, FLAMMABLE or dangerous material in the property. This restriction also applies to any storage facility situated in or attached to the block, which has been provided for your use."
- 3) No Flammable liquids stored on site by Caretakers / cleaners.
- 4) There are no flammable liquids or gas cylinders stored on site.






