Sandwell Metropolitan Borough Council: Auditor's report and closure of the audit for 2021/22.

We are pleased to be able to advise you that we have completed our audit of the Council's financial statements for the year ending 31 March 2022 and our work on your arrangements for securing economy, efficiency and effectiveness in your use of resources, together with all other work we are required to complete under the Code of Audit Practice.

We have issued an unqualified opinion on the financial statements and have reported significant weaknesses in the Council's arrangements for securing economy, efficiency and effectiveness in its use of resources as required by the Local Audit and Accountability Act 2014, the National Audit Office's Code of Audit Practice and supporting guidance.

We have issued written recommendations under section 24 of the Local Audit and Accountability Act 2014 in relation to the Governance arrangements in place during the financial year.

A copy of our auditor's report is attached, which includes our certificate of completion of the audit for the year ended 31 March 2022. Please include this auditor's report in your statement of accounts before publishing it on your website. Please ensure that you do not reproduce the signature of the auditor in any electronic format for any other purpose.
