The Cloister Memorial at Sandwell Valley Crematorium

The Cloister Memorial is a pink granite unit which has provisions for two caskets of cremated remains

In the event of non renewal of this memorial, you may collect the front fascia and the cremated remains (if applicable).

If the cremated remains are not collected they will therefore be scattered upon the gardens of remembrance at Sandwell Valley Crematorium.

Please be aware from the time of ordering it may take up to 8 weeks for delivery.
