THE BOROUGH COUNCIL OF SANDWELL

(Sandwell Borough, Consolidation of Waiting and Loading Restrictions)

(Traffic Regulation order No. 18) 2024.

The Borough Council of Sandwell ("the Council") in exercise of its powers under Sections 1, 2, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act") and under the Road Traffic Act 1991 as amended (whether generally or in relation to the area of the Council) ("the 1991 Act") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with paragraph 20 of Schedule 9 to the 1984 Act, hereby makes the following Order:-

- 1 This Order may be cited as The Borough Council of Sandwell (Sandwell Borough, Consolidation of Waiting and Loading Restrictions) (Traffic Regulation Order No.18) 2024 and shall come into operation on NNth NNNNN 2024
- 2 The restrictions imposed by this order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under any other enactment.
- 3 In this Order
 - a) "Authorised person" means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order.
 - b) "Business" means one which is registered for Business Rates.
 - c) "Civil Enforcement Officer" means an Authorised person by or on behalf of the Council to enforce the restrictions in this Order and issue Penalty Contravention Notices.
 - d) "Council" means Sandwell Metropolitan Borough Council;
 - e) *"disabled person's badge"* has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 as amended.
 - f) "Dispensation Certificate" means a Certificate or Virtual Certificate issued by or on behalf of the Council for the purposes of this Order permitting a specified vehicle to wait in specified circumstances on a length or lengths of road where the waiting of that vehicle would otherwise be restricted or prohibited;
 - g) *"driver"* in relation to a motor vehicle waiting in a parking area, means the person driving the motor vehicle at the time it was left in the parking place.
 - h) *"electronic communications network"* has the same meaning as in the Communications Act 2003.
 - i) *"goods vehicle"* means a motor vehicle not exceeding 2.3m in height or 5.25m in length, which is constructed or adapted for use for the carriage of goods or of burden of any description and is not drawing a trailer.
 - j) "Handheld Device" means a handheld computer (including mobile phone) used by a Civil Enforcement Officer whilst carrying out duties which is programmed to interface with the Telephone or Electronic Payment System operator;
 - k) *"household"* means the occupants of a dwelling used or suitable for use as a separate dwelling.
 - I) *"junction"* means the intersection of the outside edge of the first highway with the outside edge of the second highway.

- m) *"Motor cycle"* has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984.
- n) *"motor vehicle"* has the same meaning as in Section 136 of the Road Traffic Regulation Act 1984.
- o) "Organisation" means an Organisation concerned with the care of disabled persons to which a disabled person's badge may be issued which has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) (Amendment) Regulations 2007
- p) *"Organisational Badge"* means a disabled person's badge issued to an Organisation.
- q) "Owner" has the same meaning as Section 92 of the Traffic Management Act 2004, and Owner shall have the meaning in the The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022 in respect of a person who is served a penalty charge notice
- r) *"Parking disc"* means the disc issued by the Local Authority complying with the requirements of Regulation 8(5) of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 and capable of
- s) *"parking place"* means the part of a road authorised by the Order to be used for the purposes of parking a motor vehicle.
- t) "Parking Ticket" means a ticket lawfully obtained from a Ticket Machine provided by the Council for the issue of Parking Tickets appropriately dated and time stamped relating to Schedule 18a of this Ordrer or obtained by the
- "penalty charge" has the same meaning as in The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022 or any subsequent legislation so enabling;
- v) "penalty charge notice" means a notice issued by a Civil Enforcement Officer pursuant to The Civil Enforcement of Road Traffic Contraventions (Approved
- w) "Permit" means a Permit or Virutal Permit issued by the Council under the provisions of this Order;
- x) *"permit holder"* means a person to whom a permit has been issued under the provisions of Clause 18/09, 18/10 and 18/11 of this Order.
- y) "relevant position" in respect of: (a) a disabled person's badge and Parking disc has the same meaning as in the
- z) "Service Provider" or "Agent" means the contractor authorised by the Council to accept payment of the parking charge, either for a Parking Ticket, or a Permit or both, on its behalf and to keep a record of that Parking Charge and the vehicle, Parking Place and the parking period in respect of which payment has been made using the Telephone or Electronic Payment System;
- za) *"taxi"* has the meaning given by Schedule 1 of the Traffic Signs Regulations and General Directions 2016.
- zb) *"ticket machine"* means an approved ticket issuing machine provided by the Council for the issue of parking tickets appropriately dated and time stamped.
- zc) *"traffic sign"* means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the Road Traffic Regulation Act 1984.

- zd) *"universal service provider"* has the same meaning given by Section 65(1) of the Postal Services Act 2011.
- ze) "unattended vehicle" means a vehicle where the driver has left the driver's seat save to push a broken down vehicle
- zf) "Virtual Certificate" means an electronic record of a Certificate issued by or on behlf of the Council permitting a specified vehicle to wait in specified circumstances on a length or legths of road where the waiting of that vehicle would otherwise be restricted or prohibited;
 zq) "Virtual Dispensation Certificate" means an electronic record of a Certificate or
- zg) "Virtual Dispensation Certificate" means an electronic record of a Certificate or Virtual Certificate issued by or on behalf of the Council that is required to be accessible using a Handheld Device on an electronic database approved by the council for the purposes of this Order permitting a specified vehicle to wait in specified circumstances on a length or lengths of road where the waiting of that vehicle would otherwise be restricted or prohibited;
- zh) "Virtual Permit" means an electronic record of a Permit issued and confirmed by the Council that is required to be accessible using a Handheld Device on an electronic database approved by the council to exempt a vehicle from a restriction under the provisions of this Order;
- 2g) "Virtual Season Ticket" means an electronic record of a Season Ticket issued and confirmed by the Council that is required to be accessible using a Handheld Device on an electronic database approved by the Council to exempt a vehicle from a restriction under the provision of this Order.

Section 1: No waiting at any time

- **1/01.** Subject to the provisions of this section no person shall, except upon the direction of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any motor vehicle to wait at any time in the sides and lengths of roads referred to in Schedule 1 to this Order.
- 1/02. For the purposes of Clause 1/01, a motor vehicle shall be taken to wait on a length of road if
 - i) the motor vehicle is stationary; and
 - ii) any point in that length of road is below the vehicle or its load (if any).
 - iii) "For the purposes of **Clause 1/01**, a further contravention shall be created if the motor vehicle remains on a length of road, it will be considered a new contravention from midnight on a rolling/daily basis.
- **1/03.** Nothing in **Clause 1/01** of this order shall render it unlawful to cause or permit any motor vehicle to wait as specified therein for so long as may be necessary -
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable the vehicle to be used for the purposes of
 - i) any building operation, demolition or excavation;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of a road;
 - iv) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;
 - v) the collection of household refuse from, or the cleaning of cesspools at, premises situated on or near the sides and lengths of roads specified in Schedule 1 of this Order;
 - (c) to enable a vehicle, which is a universal service povider for the collection or delivery of postal packets in the course of a universal postal service.;
 - (d) to enable goods to be loaded onto or unloaded from the vehicle;
 - (e) to enable a motor vehicle to be used for police, ambulance, fire brigade, local authority, parking attendant/civil enforcement officers or water authority, sewage authority and national rivers authority purposes, when used in pursuance of their statutory powers or duty.
- 1/04. Nothing in Clause 1/01 of this Order shall render it unlawful to cause or permit a motor vehicle which displays in the relevant position, a valid disabled person's badge and a parking disc (on which the driver or other person in charge of the motor vehicle has marked the time at which the period of waiting began) to wait in the sides of lengths of road referred to in Schedule 1 for a period not exceeding 3 hours (provided that this waiting is not during a period separated by an interval of less than 1 hour from a previous period of waiting by the same motor vehicle in the same sides of lengths of road).

 - (a) for a period exceeding the length of time specified in **Column 6** of **Schedule 5**;
 - (b) during any period separated by an interval of less than the duration specified in Column
 7 of Schedule 5 from a previous period of waiting by the same motor vehicle in the same side and length of road.
- **5/02.** For the purposes of **Clause 5/01**, a motor vehicle shall be taken to wait on a length of road if
 - i) the motor vehicle is stationary; and
 - ii) any point in that length of road is below the vehicle of its load (if any)
 - iii) "For the purposes of Clause 5/01, a further contravention shall be created if the motor vehicle remains on a length of road at the beginning of a period in which vehicles may be left there in pursuance of the order and shall be treated as if it had been left there at the beginning of that period."
- **5/03.** Nothing in **Clause 5/01** of this order shall render it unlawful to cause or permit any motor vehicle to wait as specified therein for so long as may be necessary -
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable the vehicle to be used for the purposes of
 - i) any building operation, demolition or excavation;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of a road;
 - iv) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;
 - v) the collection of household refuse from, or the cleaning of cesspools at, premises situated on or near the sides and lengths of roads specified in Schedule 5 of this Order;
 - (c) to enable a vehicle which is a universal service provider for the collection or delivery of postal packets in the course of a universal postal service.
 - (d) to enable goods to be loaded onto or unloaded from the vehicle;
 - (e) to enable a motor vehicle to be used for police, ambulance, fire brigade, local authority, parking attendant/civil enforcement officers or water authority, sewage authority and national rivers authority purposes, when used in pursuance of their statutory powers or duty.
- **5/04.** Nothing in **Clause 5/01** of this Order shall apply to a vehicle that is displaying in the relevant position a valid disabled person's badge.

- **8/01.** Subject to the provisions of this section, no person shall, except upon the direction of a Police Officer in uniform or of a Civil Enforcement Officer, cause or permit any motor vehicle to wait in the sides and lengths of roads referred to in Schedule 8 to this Order during the hours prescribed in Column 5 of the said schedule.
- 8/02. For the purposes of Clause 8/01, a motor vehicle shall be taken to wait on a length of road if
 - i) the motor vehicle is stationary; and
 - ii) any point in that length of road is below the vehicle of its load (if any)
 - iii) "For the purposes of Clause 8/01, a further contravention shall be created if the motor vehicle remains on a length of road at the beginning of a period in which vehicles may be left there in pursuance of the order and shall be treated as if it had been left there at the beginning of that period."
- 8/03. Nothing in Clause 8/01 of this Order shall render it unlawful to cause or permit any motor vehicle that displays a valid disabled person's badge in the relevant position, and a parking disc (on which the driver or other person in charge of the motor vehicle has marked the time at which the period of waiting began) to wait in the sides and lengths of roads referred to in Schedule 8 to this Order for a period not exceeding the length of time specified in Column 6 of Schedule 8.
- 8/04. Nothing in Clause 8/03 of this Order shall apply to any motor vehicle waiting in the sides and lengths of roads referred to in Schedule 8 to this Order during a period separated by interval of less than the duration specified in Column 7 of Schedule 8 from a previous period of waiting by the same motor vehicle in the same side and length of road.
- **8/05.** Nothing in **Clause 8/01** of this order shall render it unlawful to cause or permit any motor vehicle to wait as specified therein for so long as may be necessary -
 - (a) to enable a person to board or alight from the vehicle;
 - (b) to enable the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with
 - i) any building operation, demolition or excavation;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of a road;

Section 18: Residents' Parking.

- 18/01. Except as provided for in Clause 18/02, the parts of roads specified in Schedule 18 to this Order are authorised to be used for the purposes of parking a motor vehicle displaying a valid permit and subject to the following provisions of this section, as a parking place for such classes of motor vehicles in such positions as specified in Schedule 18 and during the hours prescribed in Column 5 in the said schedule.
 - (a) "For the purposes of **Clause 18/01**, a further contravention shall be created if the motor vehicle remains on a length of road at the beginning of a period in which vehicles may be left there in pursuance of the order and shall be treated as if it had been left there at the beginning of that period."
- **18/02.** Nothing in **Clause 18/01**, shall restrict the power of the Council or a person designated by the Council to suspend the use of the parking place or any part thereof whenever he/she considers such suspension reasonably necessary -
 - (a) for the purposes of facilitating the movement to traffic or promoting its safety;
 - (b) to enable a motor vehicle if it cannot conveniently be used for such purposes in any other road, to be used in connection with
 - i) any building operation, demolition or excavation;
 - ii) the maintenance, improvement or reconstruction of a road;
 - iii) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication system lawfully kept installed in any position;

- **18/11.** Where in the opinion of the Council or a designated officer of the Council a motor vehicle is required to be parked in the sides and lengths of streets specified in Schedule 18 to this Order in connection with the operation of a Business, a Special Business Permit may be issued to an applicant for the parking of that motor vehicle in the parking places contained in that street or any other parking place in a street of the same zone as specified in Column 6 of Schedule 18 to this Order. A special Business permit shall be issued at the discretion of the Council and only upon receipt of an application form from a designated office of the Council. The application shall include the particulars and information required by the form together with the fee specified in Schedule 18B to this Order.
- 18/12. At all times during which a motor vehicle is waiting (other than a motor vehicle which is otherwise exempted by this Order) in a parking place on such days and during such hours as are specified in Column 5 of Schedule 18 to this Order, a valid permit shall be displayed such that the relevant particulars are readily visible from the front or the nearside of the motor vehicle and can be read by any Parking Attendant carrying out his normal enforcement duties.
- **18/13.** A permit shall cease to be valid on the occurrence of any one of the events set out below -
 - (a) the permit holder ceasing to be a resident, in the case of a residents' first, second or third permit;

 - (b) to enable a motor vehicle if it cannot conveniently be used for such purposes in any other road, to be used in connection with

except upon the direction of a Police Officer in uniform or a Civil Enforcement Officer.

- **19/06.** Except as provided in **Clause 19/09**, the following provisions relate to all motor vehicles having more than 2 wheels.
 - (a) Subject as hereinafter provided the driver of a motor vehicle waiting in a parking place specified in Schedules 19 and 19A to this Order, during the hours specified in Column 5 in the said schedules, on leaving the motor vehicle in that parking place, must pay the daily charges specified in Schedule 19B, by the insertion of a coin or coins for the period required into the ticket machine approved in accordance with Section 35(3) of the Act of 1984, and the provisions of Section 47(5) of the Act of 1984 shall apply in respect of such apparatus namely:
 - i) Parking Places specified in **Schedule 19** to this Order- For any one visit charges as specified in **Schedule 19B** to this Order.

- **19/08.** No person shall use any parking ticket or tickets issued in respect of a motor vehicle left in a parking place specified in **Clause 19/01** in relation to any other motor vehicle.
- 19/09. Nothing in Clause 19/06 of this Order shall apply to a vehicle which displays :-
 - (a) a disabled person's badge, in the relevant position, to wait in the sides of lengths of road referred to in **Schedules 19 and 19A**
