The Woodland Sanctum Memorial with Single Garden at Sandwell Valley Crematorium

The Woodland Sanctum Memorial with single garden is a freestanding wine granite memorial. Each memorial has a black granite fascia which is inscribed in either silver or gold lettering in memory of a loved one.

It is possible to have two sets of cremated remains interred inside the Sanctum.

In the event of non renewal of this memorial, you may collect the front fascia and the cremated remains (if applicable). If the cremated remains are not collected they will therefore be scattered upon the gardens of remembrance at Sandwell Valley Crematorium.

Please be aware from the time of ordering it may take up to 8 weeks for completion.

Please note that payments must be made in full in order for the memorial to be ordered. Payments can be made by Cash, Switch/MasterCard/Visa or Cheque made payable to **Sandwell MBC**.
